Directions to Canine Affair Center

From the West—Take Rt. 480 East to Rte. 271 North to Mayfield Rd. East.

-OR- Take 90 East to 271 South to Mayfield Rd. East. Stay out of the Express Lanes.

Then take Mayfield Rd East to Rt. 306 North (Chillicothe Rd) to Mulberry Rd. Turn Right on Mulberry Rd and follow directions “for all” below.

From the East—Take Rt. 80 West to Rt. 44 North to 422 East to Rt. 306 North (Chillicothe Rd) Head north through the townships of Newbury & Chesterland. Turn right on Mulberry Rd and follow directions “for all” below.

-OR- Take Rt. 90 West to Rt. 306 South (Chillicothe Rd). Head South through Kirtland and **WATCH YOUR SPEED**. Turn left on Mulberry Rd and follow directions “for all” below.

For all—As you are heading east on Mulberry Rd, turn at the driveway before the large sign for Aerotech on the right. Follow the long driveway around a curve to the right to the buildings in the back. Canine Affair is on the left end of the building on the left.

Registration & Refunds

- There are 24 working spots. Working spots will be filled in the order received. There are unlimited audit spots.
- Registration fee includes:

 - Registration fee for working and audit spots is \$140.00

Note: There is no reduced registration fee for auditors since most of the registration fee is covering seminar expenses.
- **Deadline for receipt of registration is May 1, 2023.** Payment is due with registration.
- Refunds will be issued if requested by e-mail or phone before May 1, 2023. If refunds are requested, a \$25.00 administrative fee will be retained.

Prerequisites for a Working Spot:

- Dog must not be aggressive toward people or other dogs.

Dog Etiquette

- Crating space is limited. If you are bringing more than one dog, please be prepared to stack crates if needed.
- Auditors are encouraged to leave their dogs at home if possible.
- All dogs must be crated and quiet when not working. If your dog cannot be crated and remain quiet, please don't bring your dog.
- Please bring some type of floor covering. No crates should be placed directly on the matted floor. Crates may be left in the building Friday and Saturday nights.
- Any dog that is disruptive or behaves in an aggressive manner as determined by event staff will be asked to leave.
- PLEASE clean up after your dog at the training center and at hotels: no excuses!
- Participants should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Proof of vaccination should be available, if requested.

People Etiquette

- Please turn off all cell phone and pager audio alerts during the seminar and take all private conversations outside the seminar room.
- Plastic chairs are available. You may bring a chair of your own but please do not bring high-backed or oversized chairs.
- Participants will be encouraged to have someone video their work on their own phone or tablet.

I (we) acknowledge that the CFF Regulations for Freestyle Competition have been made available to me (us), that I (we) are familiar with their contents, and that I (we) agree to abide by these Regulations at this CFF Freestyle Competition. I (we) waive any and all claims or causes of action I (we) might otherwise have against CFF and any CFF approved judge, judging at this competition under CFF Regulations for Freestyle Competition. I (we) agree that CFF has the right to refuse this entry for cause which CFF shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the freestyle competition and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold CFF, its members, directors, governors, officers, agents, superintendents or secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury or illness, (COVID included) which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the competition premises or grounds or near the entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless for any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of CFF or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.
